Chosen films will be shown in Lahti 28.-30.3.2008. Other possible rights for presentations will be handled individually with makers and producers of the film with different agreements</p> <p><b>Giving rights for screening</b> Authors and their representatives will assure that they have necessary authorisation for giving rights for screening. Film makers are also held responsible for getting permits for the music in their films.</p> <p><b>Liability for damages</b> Film makers will compensate possible payments caused by copyrights or copyright holders to Päijät-Hämeen elokuvakeskus or its co-workers and operators according to damages.</p> <p><b>Validation of agreement</b> Contract is valid 28.-30.3.2008. All the parties of agreements can give terminate agreement in two week period of notice. Termination doesn't need explanations.</p> <p><b>Solutions for disagreements</b> Disagreements from contract or breaking the contract will be solved in court of Lahti.</p> <p>This contract is delivered with screening copy to Päijät-Hämeen elokuvakeskus.</p>
